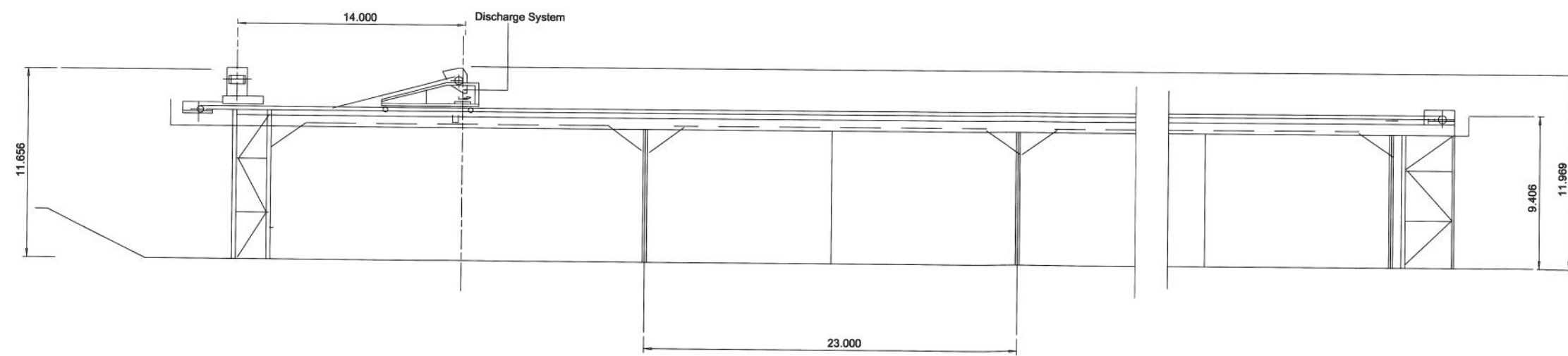


View at A - A Section through Aggregate Storage
